

Notice of Race Flying Scot - Scot-a-Hoochee and **Lightning - Atlanta Cup** Regatta

September 24 - 25, 2016





Flying Scot Fleet #111 and Lighting Fleet #348 and Lake Lanier Sailing Club (LLSC) cordially invite you to attend the 2016 Scot-a-Hoochee and the Lightning Atlanta Cup Regatta on Sept 24–25, 2016.

Eligibility: Flying Scot and Lightning class sailboats from any District in compliance

> with class rules will be scored. Eligible boats may enter by completing the attached registration form and submitting it with the required fee by the

close of the Registration Table on September 24, 2016.

Rules: The regatta will be governed by the rules as defined by the 2013-2016

Racing Rules of Sailing (RRS), the prescriptions of US Sailing, the one design rules of the Flying Scot Sailing Association or the International Lightning Class Association (ILCA) and this Notice of Race except as amended by the Sailing Instructions. Sailing instructions will be provided

at check-in.

VHF Radios: VHF radios may be carried aboard. Radio communication from a

> competitor during a race is not permitted except for an emergency or to retire. The VHF channel for communications will be Channel 69. Race committee broadcast concerning its intentions, the course to be sailed, starting times, course changes, etc. are a courtesy only. After the starting signal, the Race Committee may attempt to hail boats (including by VHF radio) that are OCS and boats that have not complied with RRS 30.1. Failure of the race committee to make a broadcast, the timing of a

> broadcast, or the failure of a boat to hear a broadcast shall not be grounds

for redress. This changes RRS 62.1(a).

Registration/Fees: The entry fee for Flying Scots (which includes 2 meal packages) is \$60 for

pre-registration.

The entry fee for Lightnings (which includes 3 meal packages and SELD

fee of \$7) shall be \$97 for pre-registration.

To be eligible for pre-registration, the registration form must be received by mail or email before midnight of Wednesday, September 21, 2016. To register use the form below.

Registration includes Friday evening hors d'oeuvres, continental breakfasts each morning, Saturday lunches and dinners, and Sunday's lunch leftovers and hot dogs! Additional meal packages are available for purchase.

Scoring: The Low Point system as specified in Appendix A2.2 and A5 will be used

except that all races will be scored.

Racing Area: Racing will take place in the vicinity of Chattahoochee Bay and main

channel on Lake Lanier.

Alternative Penalties: The 720 Turns penalty as modified by Class rules will apply.

Trophies: The skippers and crews of the top three finishing boats will receive

awards. A single race will constitute a regatta for the purpose of

recognizing winners and awarding trophies.

Accommodations

Launching: LLSC has two boat ramps at Lots A and B. See a map of grounds

Directions: LLSC is located off Interstate 985 near Flowery Branch approximately 40 miles

north of Atlanta.

From Atlanta, take I-85 North to I-985. Go 11 miles to Exit 12, Flowery Branch. Turn left under the expressway bridge and continue on Sprouts Spring. Go 0.7 miles to Atlanta Highway. Turn right for 0.2 miles to Spring Street; turn left and cross the railroad tracks; continue past the Methodist Church to the dead end at Gainesville Street. Turn right, follow road for 0.8 miles to stoplight at McEver Road. Cross McEver through light (road name changes to Jim Crow Road and again to Old Federal Road);

*continue for 2.4 miles to white rail fence at the sailing club on left. Landmarks include Pop's Stop on the right and an Old Federal Park sign before the sailing club.

From South Carolina, take I-85 South to exit 129, Hwy 53 - Braselton. Turn right; continue for approximately 12 miles through a small shopping area, passing under I-985 and continue on Mundy Mill Road (a four lane road) to McEver Road. Turn left onto McEver Road. Continue approximately 4 miles past a high school; look for signs to Old Federal Park and Flowery Branch Elementary School. At the stoplight at Jim Crow Road, turn right. Chevron Station and Liquor store on right (The road to the left is Gainesville Street). Continue as above at *
