

## ANOTHER IN OUR FSSA SERIES OF BIOGRAPHICAL SKETCHES



Your National Treasurer, J. Fred Weintz, Jr. is an investment banker residing in Riverside, Connecticut. He is a partner of Goldman, Sachs & Co. in charge of new business development in the east central quarter of the United States. Fred holds an A.B. from Stanford 1948 and M.B.A. from Harvard Business School 1951. He and his wife, Betsy, have four children - two boys and two girls.

Fred's first boat was a Comet purchased in 1942 when he was 16. He sailed it 2 years out of Huntington (L.I.) Y.C. and then joined the U.S. Army Air Forces. After the war, he did little sailing until he bought F/S #222 "Deuces Wild" in the spring of 1961. He and Betsy have been avid "Scotters" ever since, participating in most Fleet 7 races, all three Northeast District Regattas held and every National Championship from 1962 to date. He was elected Fleet Captain in 1965, ran the 1965 District Regatta, and is serving his second term as National Treasurer. He belongs to the Riverside Yacht Club, Y.R.A. of Long Island Sound and the North American Yacht Racing Union.

Outgoing FSSA President, William E. Claypool reports on the Annual Meeting and the Board of Governors Meeting held at Cleveland, Ohio on August 16, 1966, as follows: -

The two amendments were approved - (1) Gordon K. Douglass was made a member of the Governing Board and (2) the minimum measurement for the rudder blade is 25". The slate of new officers was passed unanimously. Ratified without opposition the Board of Governors' By-Law amendment to permit the National Race Committee to hold make-up races any day. Treasurer Fred Weintz summarized his report, noting that we were in "good shape" financially. After a discussion of the possible revocation of Toledo Fleet 26, it was decided that the Charter be maintained on a provisional basis. Dave Rodenkirk asked for consideration of fixing the crew at three - no action taken. And notes from the Board of Governors Meeting included - urgency to make 1967 Nationals reservations promptly; jacket or cap patches now available at \$2.00 from Fred Weintz; Texas-Kan-sas-Oklahoma recognized as a new district; and it was decided that when any two or more districts hold regattas, they may hold a sanctioned regional regatta the same year; all members asked to help with personal approaches to aid the FSSA membership drive; expected that first year's FSSA membership will be included in a flat fee with boat registration.

Miscellaneous news and notes of interest - - - Tom Meaney and Bill Claypool are planning to draw up a Regatta Manual - - - Annual FSSA Fleet Reports are due in January 1967, with forms going out to the fleets soon - - - Working with Johnnie Jones and others on a F/S booklet containing salient articles on sailing - - - Sandy suggests, with the New York Boat Show running from January 14-22, that the FSSA Winter Meeting be held Friday evening, January 20, 1967 - - - Chicago Tribune of October 9th reports an extra 1,000 workers added that week-end to break the huge backlog of mail at Chicago's main post office, which was mostly 3rd class bulk mail and included SCOTS N'WATER October issue - hope yours arrived eventually - - - Letter just received from Sandy dated April 4, 1966, coming via devious route, states that there is a new SCOT builder - Ranger Fiberglass Boats, 25802 Pacific Highway South, Kent, Washington; it appears from the lists that they are already in F/S business, and we wish them every success - owner is Mr. Howard Smith - - Some back issues of S&W are available and are yours for the asking, as we might just scrap most of them - - Thanks, Mrs. McGraw for your note about the past issues requested and recently received at Bloomfield Hills - - That's it for this month's miscellaneous!

Yes, we have now received the news on the latest SCOT fleet - No. 57 which sails on Nantucket Sound out of Stonehorse Yacht Club at Harwichport, Mass. Fleet Captain is Charles A. Winans, who also acts as Correspondent, and Robert Leavitt is Measurer. Charter members, in addition to Messrs. Winans and Leavitt, are Arthur N. Gorham, William S. Kimball, Arthur V. Cote, Everett Jenkins, John J. King, Rodger P. Nordblom and Richard Hosmer. Charles Winans informs us that the new fleet got off to a fine start July 4th week-end, and has been racing seven boats practically every Saturday-Sunday since. Extra curricula sailing has also included the Marthas Vineyard Regatta with nine SCOTS participating and the Wild Harbor Yacht Club Regatta on Buzzards Bay. Sounds like Fleet 57 will be one of our top fleets, with such an excellent start.

DR. FORD W. STEVENS received hearty applause from all present for making the F/S Border Trophy Regatta and the entire week-end such a tremendous success. Results of the regatta held on August 6-7 at the Trident YC, Gananoque, tario were reported in the September S&W. Vice commore Stevens was a little disappointed that only nine SCOTS competed. He would like suggestions from interested SCOT sailors whether a similar regatta should be planned at Trident in 1967, with the Flying Scot Nationals being in Montreal. CARLTON D. CHAPMAN writes in, giving information about the new FLYING SCOT PRAIRIE DISTRICT, starting off with F/S Fleets 39-50-55, and Fleet 50 the sponser of the 1967 Districts in June at the Oklahoma City Boat Club. Fleet 50's final race of the 1966 season, on October 30th, had as its trophy a half gallon of Scotch donated by outgoing Fleet Captain Ed Kerr, with the stipulation that it all be consumed by the participants and the winner's name to be engraved on the empty bottle. The new District is already active, sanctioning races on Grand Lake October 1-2, with eight SCOTS present, but only five racing the second day because there weren't enough crew members present to keep all of the boats baled out in the 40-55 mile winds - and no one capsized!

Sandy Douglass passes on a complete report of the President's Cup Regatta held at Washington, D.C., with 21 SCOTS competing; more would have been there had there not been conflict with the Carolina Sailing Club Regatta the same dates, September 17-18. That well known West Virginia Prosecutor Don Hott came up with a 1-3-1 to win first place in an enjoyable regatta even though winds were 2-3 mph in the first two races but way up to a brisk 5 mph for the final race - hardly planing weather. Evening cocktail parties were enjoyed at the Emmett Echols' and the Archer Taylor's. Sandy crewed for Charlie Nance of England, here on a tour of duty with the Royal Air Force, an ex-Thistle sailor. Vince DiMaio placed first in the second race. Final standings were, in order, - Hott - Nance - DiMaio - Gibbs - Rich - Ammann - Krevitz - Williams - Beelar (with a 2nd and a 3rd, but withdrew in the last race) - Anderton - Manee - Echols - Gallaher - Moreland - Doherty - Cowie - Votaw - Overholser - Huston - Taylor - Kooman.

After nearly a year, we have received a most welcome letter from Kil Adams, who did such a fine job of reporting when he lived in Dallas and sailed with F/S Fleet 23. Kil reports on the 2nd Annual Landlubber Regatta held on October 1-2 on Lake Thomas, a part of the Colorado River about 75 miles from Abilene, Texas, and states that this year there were three SCOTS present so they raced as a Class Series. It is likely that a request for a fleet charter will be forthcoming according to Kil, who incidentally took first place in the Regatta for the SCOTS, Beaumont Cooley, #923, was second and Bill Young, #925 took third place. Kil mentions that the SCOTS made a creditable showing and opened the eyes of many of the elite Thistle experts who founded the club. He also has high praise for expert sailplane pilot Beau Cooley who finished in 2nd place for the summer handicap series at the Lake Thomas Yacht Club, winning over all Thistles, Flying Dutchmen and Y-Flyers on a corrected time basis, except for one Thistle, and many times on a boat for boat basis.

Orville White has a few comments to add from Montreal: - - It is expected that the Flying Scots will be one of the largest one-design regattas at Expo 67-in August '67, being one of the six international championships out of the total seventeen championships to be sailed - - The Hilton family rate mentioned elsewhere at \$20.00 will include a family of four and possibly "a trundle bed for another child" - - It is necessary to take the reservations for the entire week, with a \$20.00 deposit required. - - SCOTS from Texas, Maryland, Ohio and New York have already signed up.

Orville also reports that their HIKING STRAP experiment in 1966 at Montreal resulted in that they are "a true safety factor and should be known as security straps and the longer handlines are exceptionally good."
